3. Public Comment on Non-Agenda Items

Linda Scharf expressed interest in the building site of the new Fire Station. She questions if there needs to be a 100 foot barrier and if the builders will be taking the habitat into consideration as they prepare the site.

Chief Goodwin states there will be some replanting of trees after the building is constructed and he is not aware of the 100 foot barrier that Linda Scharf is questioning but he will look into it.

Len Gay states he is disappointed that there has not been a District Report done for the last several years and would like to suggest going back and re-creating the reports. The Prudential Committee asks for it to be placed on the agenda for discussion at the next meeting.
