## 1. Open Meeting with Pledge of Allegiance

Chairman Frank Kowzic opens the meeting at 5:15PM with the Pledge of Allegiance. Present are Ken Fontes Clerk, Attorney David Gay, Clerk-Treasurer Mary E. McCoy, Melissa Goodell Administrative Assistant. Member Ben Hughes conferenced by phone at 5:45PM.

2. Executive Session under M.G.L. c30A Section 21(a)(2) to conduct strategy sessions in preparation for negotiations with nonunion personnel namely contingency plans for interim Water Superintendent.

Frank Kowzic motions to stay in Open Session and not convene into Executive Session. Ken Fontes seconds the motion, vote 2-0-0, Ken Fontes yes, Frank Kowzic, yes.

Attorney Gay states the meeting was called as an emergency because all efforts to extend the current superintendent's employment beyond his leave date have failed. The Water Department now needs to put in place a plan since they will be without a Superintendent and the necessary licenses effective August 9, 2019.

Attorney Gay states there are a couple of ways to proceed:

- 1. Appoint an interim Superintendent from the applicants. (there is only 1).
- 2. Consider appointing someone from the Board of Water Commissioners. Ken Fontes states he would be comfortable appointing the Chairman of the Water Commissioners to oversee the day to day operations until there is a more permanent solution. Ken Fontes states there are consulting firms that can provide the licensing services in the interim.

Ben Hughes conferences in: Ken Fontes and Attorney Gay brief him on the discussions so far.

Ben Hughes thinks it is a wise decision to move ahead with Chairman Kowzic overseeing the day to day operation of the Water Department and hiring a consulting firm for licenses. Both Ken Fontes and Ben Hughes state they also will be available to assist Chairman Kowzic.

Attorney Gay reinforces the importance of moving ahead slowly and making the correct decisions.

Ken Fontes motions that effective immediately the Board of Water Commissioners will oversee day to day operations of the Water Department and Chairman Frank Kowzic will be the point person for the employees to go to. Ben Hughes seconds the motion, vote 2-0-1 with Frank Kowzic abstaining.

Ken Fontes motions to adjourn at 6:00PM. Ben Hughes seconds the motion, vote 3-0-0.
