3. <u>Discuss change order for Fire Station with Joe Sullivan</u>

Joe Sullivan states the reason for the change order was the sand component. The builders were required to add gravel and lift under the footings. Joe Sullivan states it is not unusual to have change orders and that is why there is a contingency allocation figured into the final budget. Marcine Fernandes indicates the Prudential Committee needs to have changes explained as well as the costs associated with them. Joe Sullivan suggests bringing changes to the Fire Station Building Committee first and then to the Prudential Committee.

Marcine Fernandes motions to pay the change order in the amount of \$43,412.10. Pamela Pike seconds the motion, vote 2-0-0. Pamela Pike yes, Marcine Fernandes yes.

Pamela Pike motions to give Marcine Fernandes authority to sign change orders less than

\$10,000.00 without bringing them before the Prudential Committee. Marcine Fernandes seconds the motion, vote 2-0-0. Pamela Pike yes, Marcine Fernandes yes.
