Attention: Treasurers (Audits and 990 Tax Filings)



Copies of the audit completed for your PTA for the 2016-2017 fiscal year should be emailed to your Regional Director at your earliest convenience. Remember, this is one of the Standards of Affiliation items the state PTA needs from your unit! They are due within 120 days of the end of your fiscal year.

It's also time to complete the 990 for your unit for the 2016-2017 fiscal year. If your PTA files a 990N (which most PTAs in West Virginia file), we have prepared a Stepby- Step Guide to help walk you through the process. We also are offering to complete the filing on your behalf! Visit the website for more details. The 990N tax filing is due five months and fifteen days after the end of your fiscal year, so for most of our units that is November 15. If you have questions, email Chris Wuest, WV PTA Treasurer, <u>treasurer@westvirginiapta.org</u> with the name of your local unit. She will walk you through the process. We are here to help!

Have you updated your Local Unit Officer Information online?

Why is it important to complete this form?

Having your officer's current information helps us keep you informed of vital information you need about resources, programs, awards, incentives, and much more!

Do I need to fill it out if our officers stayed the same?

Each year we need to ensure we have the most accurate information for all PTA's, even if your information didn't change. We want to make sure you receive everything you need to run your unit successfully!

What if we have a mid-year change?

Just notify us with our on-line form! Simply go to the link and update the information. It's that easy!

Where do I fill out the Local Unit Officer Information Form?

Can I send in the information manually and mail to the office?

Yes, of course! Make sure to include each officer's name, address, phone number and email address and remember to include the name of your PTA. These can be mailed directly to the PTA office.

Where do we send in copies of our audits? 990's? or any standard of affiliation items?

Please send these items to your regional director remembering to label which unit you are from. Your regional directors email addresses can be found in the directory at the end of the newsletter.

West Virginia PTA wishes to thank Med Express for printing our 2017-2018 Membership Cards for our members again this year! We appreciate your continuous support of our PTA members throughout West Virginia! West Virginia PTA maintains all of the essential filings for your PTA! Through our Standards of Affiliation, all local units have a central location to ensure you are meeting federal guidelines as a 501(c)(3) entity.

Each local unit or county council PTA must be in good standing with West Virginia PTA to continue to operate as a PTA and as a tax---exempt organization. In order to remain in good standing, West Virginia PTA requires six easy steps to ensure your PTA is compliant:

- Submit the annual Local Unit Officer Form (now online!);
- Submit membership dues monthly, with a payment of a minimum of ten members by October 1 of each year;
- Submit an annual review/audit of the PTA's financial records;
- Submit a copy of the annual 990 form or e-postcard;
- Submit proof of your bonding and liability insurance (if your PTA uses AIM, your information is provided automatically by AIM); and
- Submit bylaws for approval every three years.

Being in good standing is easy! It is our goal at West Virginia PTA to ensure that your PTA is running effectively and within the requirements of the government. Please use the chart below to track your Standards of Affiliation. You may direct all questions to info@westvirginiapta.org.

"Within Reach"

All children deserve opportunities to explore the arts, so we are proud to promote the Reflections Programs.



The National PTA Reflections program is PTA's cornerstone arts program. It was developed in 1969 by Colorado's PTA President Mary Lou Anderson to encourage students to explore their talents and express themselves. Since then, the Reflections Program has inspired millions of students to reflect on a specific theme and create original artwork.

Each year, students in Grades Pre-K through 12 are recognized for bringing the theme to life through dance choreography, film production, literature, music composition, photography and visual arts. In 2012, the Special Artist Division emerged as an optional division for students whose physical, cognitive, or mental health challenges meet ADA guidelines.

The arts—and the National PTA Reflections program, in particular—can be a valuable tool for building stronger partnerships in your school community.

Why should you host an ESSA Education Event in your school or community?

West Virginia PTA is working on educating all parents in our state on the Every Student Succeeds Act (ESSA), College and Career Readiness (CCRI), and how you can expand upon your advocacy efforts in your community. There is NO COST and we'll even bring the refreshments!

Parents likely have questions about ESSA and what that means for their child and school. For the first time, ESSA acknowledges the critical role that parents and other community members play in student success by requiring that they are involved in the implementation process. As a PTA leader, you can educate and empower families to be informed and get involved in the implementation of the new law. Federal funding for public education programs has remained at 2% of the federal budget for decades, despite the increase in public school enrollment & the rising cost of education resources and services. This disparity between funding levels and actual costs means that the federal government has essentially enacted cuts to classrooms.

The federal government's deadline to fund the government for the next year is Sept. 30, 2017. If you would like the United States to have a strong economy powered by a well-educated workforce that can compete on the global stage, then stand with four million parents, teachers, students and community leaders as we demand that Congress #STOPCutsToClassrooms and invest more than 2% in public education before the next fiscal year on Oct. 1, 2017.

Positive school climates exist in schools where students, families and educators all work collaboratively to build a culture of **respect**.



National PTA Announces STEM Families Grant Program

\$100,000 in funding will be awarded to PTAs across the country to increase family engagement in STEM.

ALEXANDRIA, Va.—National PTA announced today that \$100,000 in funding will be awarded to PTAs across the country this school year to increase family engagement in science, technology, engineering and math (STEM) education. The funding is part of National PTA's <u>STEM + Families</u> initiative.

"We know—and decades of research proves—that families play a critical role in children's success. We also know that parents and guardians have the biggest influence on a child's educational and career decisions," said Jim Accomando, president of National PTA. "Family engagement is essential to strengthen STEM education, bridge the STEM gap and help all children realize their fullest potential. National PTA is excited to further our STEM + Families initiative and equip PTAs and schools nationwide with resources to engage families in STEM education."

With the funding, PTAs and schools will:

- Engage families using hands-on learning experiences at PTA STEM + Families Events
- Educate families about STEM literacy, STEM careers and STEM education pathways and empower them to support their children's success in STEM
- Connect families and students to STEM enrichment and professional mentors

The funding will be granted in phases. An initial 35 \$1,000 <u>National PTA STEM + Families Math</u> <u>Grants</u>, sponsored by Mathnasium, will be awarded this fall to council and local PTAs selected through a Request for Proposals (RFP) process. The deadline to apply for this first wave of grants is Aug. 31, 2017.

"Mathnasium is excited to build on our relationship with National PTA by sponsoring the STEM + Families Math Grants," said Peter Markovitz, founder and chief executive officer of Mathnasium. "We're honored to work side by side with the dedicated parent leaders of PTA to engage families in math nights, promote the awareness of STEM education and careers, and pursue our mission that all children should understand and master math."

Another \$65,000 in National PTA STEM + Families Science Grants, sponsored by Bayer, will be awarded to state, council and local PTAs selected through a second RFP that will be launched later in the 2017-2018 school year.

In addition to the grant program, National PTA is pleased to announce that logic and STEM game maker ThinkFun has become a new supporting sponsor of STEM + Families. As part of ThinkFun's support of the initiative, the company will donate educational games to all National PTA STEM + Families grant recipients in the coming school year.
