- ___ Have you read and understand the rules and regulations? [Found at www.fairwayoaks.net]
- ___ You have listed ___ persons who will be residing in the unit at _____.
- ___ Do you understand that any new resident would need a new lease and an application and Board approval?
- ___ Do you understand only two (2) people unrelated may live in each of our units?
- ___ Tenants are allowed guests for a maximum of two (2) weeks only.
- ___ Vehicles: A copy of the registration is needed which matches the tags. All vehicles must have a decal placed in the right rear window or a visitors pass hanging from the front mirror.
- ___ No commercial vehicles are allowed to be parked in Fairway Oaks except those conducting business within a unit during the day. NONE allowed over night.
- ___ Guest vehicles staying after midnight must have a temporary parking pass. See Night Watch
- ___ Two parking spaces marked in front or near units are for your own vehicles or your guests.
- ___ If more than two vehicles are to be parked, they must park in marked guest spaces only.
- ___ No Parking on the grass at any time. Those vehicles will be immediately towed!
- ___ No mechanical work on vehicles is allowed.
- ___ No Motorcycles or scooters are allowed in Fairway Oaks at any time.
- ___ Speed limit on Fairway Oaks private roads is 10MPH.
- ___ Pool entry is by personal key only. Guests must be accompanied by resident 18 yrs. or older.
- ___ Children under five (5) must be accompanied by an adult while outside at all times.
- ___ Curfew is at 9:00 pm for persons under 18 years of age.
- ___ Quiet hours are from 9:00 pm until 8:00 am
- ___ Personal belongings must be inside. Lanai/patio & carport areas cannot be used for storage.
- ___ Plants and shrubs belong to the association and must not be removed without Board consent.
- ___ Trash and recycling cans and other articles for pick up go out on Wednesday after 5pm and must be brought back and stored behind your unit by Thursday evening.
- ___ Watchperson is on duty evenings to enforce the rules and regulations. His phone number is 941-350-0562 (for ANY emergency call 911- Night Watch IS NOT security or police).
- ___ Work Order Requests and Complaints (other than civil) must be on our required forms and sent or delivered to the office. All forms must be complete and signed.
- ___ All pets must be on a leash. There is a designated doggie walk. You must pick up after your pet immediately at all times.
