### Communication from Audience:

#### Chrisie Lorree:

The smells from the neighbor's chickens and ducks are repulsive and I am not able to enjoy my yard. The neighbor lady came to my door yelling at me and threatened to sue over me painting a side of the fence that that faced my property. I did get permission from her husband last year and again this year before I painted it. My dad was with me when I asked the 2<sup>nd</sup> time. I painted it white and was careful not to drip on their side of the fence.

#### Matt Grovesteen:

I did give 313 W. Main permission to have 6 chickens or ducks in a combination, but if it became an issue with residents then they would have to go. When I stopped in to inspect, they had adopted the neighbors' chickens and had a total of 12 chickens and ducks. I mentioned she had to get rid of 6 of them and to move the coop to the other side of the yard to detour the smell to the other side. I will follow up this week to make sure they got rid of the extra animals and moved the coop. If this issue is not resolved; then I may have to revoke the approval for them to have the chickens/ducks.

# Matthew Grovesteen:

Two Officers gave their resignation, Randy Nelson retired after 39 years of service and Anthony Easlick has a full-time position and is not able to work the hours we need.

Michigan Commission on Law Enforcement Standards (MCOLES) now has new protocols for hiring and comprehensive back ground checks, i.e. finger printing, drug testing, physical to make sure they can do the job. Have to contact high school teachers, coaches, families, neighbors, if in the military have to contact the miliary to check on their character and what type of person they are, also have to check financials to see how and what they spend their money on. For each person we talk to, we have to get three (3) more names and follow up with them, this would be a never-ending process. This would be a full-time job for an officer. Billy Skellenger will be in charge of hiring new officers. Jeff Lutze said we should challenge this as we do not have the funding to do this type of comprehensive back ground checks. Matt mentioned that the State needs to approve the certification for an officer to be hired by the Village of Otisville, however will check with our attorney. Keith Pyles went to court and handled the tickets. 105 W. Main was dismissed as the issues are being fixed. 115 W. Main has been give 21 days to present plans, drawing on the structure.

205 S. State the roof is starting to rot and needs to be replaced. A letter will be sent to the owner to get the roof fixed/replaced.

201 N. State – received 22 calls in one month for loud music and narcotics. Spoke with the owner and an eviction notice has been issued. The owner is going to renovate and sell the property. If the house is not emptied within 30-days of the eviction notice, the Sherriff Department will be out to put the items to the road.

Waiting for vests to come in.

The police department is in the black for the end of the year budget. We had about \$4,000.00 that went back to the General Fund.
