Dan Garman said he could give better pricing if we did not go out to bid. If we go out to bid, then the pricing comes from Corporate and it would be at a higher rate. He will also put a 2nd trash bin at the Village offices and empty them twice a week preferably on Tuesday and Fridays.

Committee Reports:

Ad hoc Committee (John Ray, Sherry Hemingway & Vadice Burgett) met with MML on Village Building Structures. Received the appraisal with the estimated premium increase. We are now properly insured on our building structures.

Matthew Grovesteen – 115 W. Main has been working on the front and back of the building and is now working on the roof. Did he get the proper permits? 115 W. Main court date is September 5th. Sherry Hemingway – We need to send a letter to the residents with the next water bill reminding them not to put lose trash in the trash cans. This is a policy with Emterra Environmental USA to ensure the safety of their employees, as they hand pick up the bags from the trash cans. Rick Ferguson – Planning Commission board met last week and inquired about a site plan for a fence at 181 N. State. Planning Commission stated to have Bobby send a letter to the owner within 2 weeks and have the owner reply within 30 days for a site plan. Bobby states that he spoke with the owner.

Vadice Burgett – We need to follow up with a letter, not just talking to residents. We need to make sure we have a paper trail if anything goes to court.

Sherry Hemingway -229 S. State is having their dumpsters emptied between 02:30 a.m. and 03:30 a.m. and is not following the ordinance.

Matthew Grovesteen – Will get the name of the garbage company and have Kathy send out a letter.
