

## How does the Program work?

- Homeowner applies through GCMPC's website at <a href="http://gcmpc.org/need-housing-repairs/">http://gcmpc.org/need-housing-repairs/</a> (No computer? Call our office for assistance)
- If the application is approved, a GCMPC Rehab Inspector will visit the property to assess the situation
- If the Inspector determines that the project can be completed within the parameters of the Program, the project will be bid out to a list of pre-approved Contractors
- Urgent repair applications are given priority over the HIP applications (whole-home repairs)



## How does the loan work?


- This is a deferred payment loan with no payments and no interest
- Loan payback amount is based on level of household income (25% of project cost up to 100% of project cost)
- A lien is placed against the property to secure the loan
- This is not a cash loan GCMPC pays the Contractor directly
- The loan is paid back when the client sells the home / transfers ownership / vacates the property
- Funding for the loan comes from the County's annual allocation from HUD



## Who qualifies and how do you apply?

- Must be the owner / occupier for a year
- · Low to moderate income household
- Taxes / mortgage / insurance must be paid current
- Can only participate in HIP or Urgent Repair Program one time


