PUBLIC COMMENT PERIOD, PUBLIC HEARING, AND OPEN HOUSES

The 90-day public comment period for the Genesee County Solid Waste Management Plan (SWMP) Amendment will be held from March 1, 2023, through May 30, 2023. During this time, copies of the Genesee County Solid Waste Plan Amendment will be made available for review at the following locations:

The Genesee County Solid Waste Management Plan is required by the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to ensure that the county can properly dispose of waste for the next ten years. More specifically, the SWMP describes materials management data, public input, deficiencies, goals and objectives to enhance materials management practices, solid waste facilities, as well as implementation strategies to improve Genesee County's solid waste system.

A public hearing will be held on April 5, 2023, at 1:00 PM in the Genesee County Administration Building, Room 222, 1101 Beach Street, Flint. This meeting is an opportunity for the public to provide input in person on the Draft Genesee County Solid Waste Management Plan Amendment.
