

# 2018 CITY OF LAWRENCEBURG Delinquent Taxes

The following is a list of uncollected City of Lawrenceburg delinquent taxes for the year 2018. The delinquent tax list will be updated on a weekly basis. This list reflects the names of the individual property owners as of January 1, 2018. Unpaid tax bills relative to properties sold or transferred after January 1, 2018, may still reflect the name of the previous owner.
