 - b. A second came from Johnny Washington

5. <u>Discussion and/or Approval</u>

- 1) Initial purchase and sales of 150 bears very successful, C4C had opportunity to purchase remaining stock of 350 bears.
 - a. Mayor Leffingwell moved to approve the additional purchase
 - b. A second came from Johnny Washington
 - c. The motion was voted on, and passed unanimously
- 2) Val Escobar brought up the preliminary plan to have a C4C retreat in January 2016 to talk about:
 - a. The organizations that C4C currently sponsors, as well as organizations we may sponsor in the future.
 - b. Possibly setting a budget for recurring sponsorships, fundraisers, and purchases
 - c. Emergencies will continue to be addressed on a case-by-case basis
 - d. A good source for information on good organizations C4C may be able to sponsor or support continues to be APD District Representative Officers
 - e. Mayor Leffingwell suggested a process be developed for organizations to submit sponsorship applications each year. All applications will be given consideration and either approved or denied.
 - f. No decision made on the C4C retreat at this meeting. Will discuss again at future board meetings.
- 3) African American Youth Harvest Foundation 3rd Annual Changing the Story Luncheon Fundraiser Sponsorship: \$5000.00 sponsorship suggested.
 - a. Mayor Leffingwell moved to approve the additional purchase
 - b. A second came from Kelly Davenport
 - c. The motion was voted on, and passed unanimously

- 4) Manos de Cristo Oct. 29th Beer, Wine & Swine Fundraiser submitted by Anthony Nelson prior to the board meeting. This is a new organization for C4C to consider supporting. The \$1000.00 "Brewmaster" is a 3rd tier sponsorship and the first tier that offers charitable recognition at the event and on the Manos de Cristo website.
 - a. Gena Curtis moved to approve a \$1000.00 sponsorship
 - b. Mayor Leffingwell moved to approve a \$500.00 2nd tier "Harvester" sponsorship
 - c. Mayor Leffingwell's motion failed for lack of a second
 - d. A second came from Johnny Washington for the \$1000.00 Brewmaster sponsorship
 - e. The original motion was voted on, and passed 4 to 1, with 0 abstaining, and Mayor Leffingwell voting against it.
- 5) 2015 Golf Tournament Project Debriefing/Feedback Discussion
 - a. Seeking C4C Board authorization to go ahead and book a golf course for August 2016
 - b. Receipts may still come in so the final fundraising amount may not be final
 - c. Board agreed that *Thank You* cards should be sent to those who donated sponsorships and raffle items.
 - d. We should find a golf course with better amenities to accommodate registration, dining, award presentations, overflow parking, and more golf carts
 - e. We should keep a trailer on site during the next golf tournament for storage and transport
 - f. Consider reconfiguring registration to allow for two lines and raffle ticket purchases
 - g. The games at the holes caused bottle-necking and delays. Consider allowing golfers to simply purchase birdies, etc.
 - h. No one brought the money from the dice game sales.
 - i. Bag pipes were very well received
 - j. Star Ranch or Terra Vista are courses that provide size and amenities.
 - k. Board will set a time next week for a thorough debrief of this year's golf tournament
- 6) C4C/APD No Shave November-December Fundraiser was/was not discussed?
- 7) Helping Hands Home Children's Home seeking sponsors to donate bicycles, iPads, MP3 players, and 20 mini-DVD players for displaced children coming to stay at the home. Chief Robledo has already found sponsors for every item except the mini-DVD players, which cost about \$50.00 each.
 - a. Val Escobar moved to approve the purchase of up to 20 min-DVD players, not to exceed \$1200.00 total
 - b. A second came from Johnny Washington
 - c. The motion was voted on, and passed unanimously
