

# ***Gibbstown School Aged Child Care***

## **COVID-19 WAIVER RELEASE**

Gibbstown School Aged Child Care takes the health and safety of our students, staff, and families seriously and require all students to follow all written and verbal instructions pertaining to attending Gibbstown School Aged Child Care.

As part of Gibbstown School Aged Child Care wish to keep all students, families, and staff safe, we ask you read and sign the form below.

By signing this form I agree that I have read, understand, and agree with the information set forth in the COVID-19 warnings below:

I state that my child/children has/have not been diagnosed with COVID-19 and, to the best of my knowledge, has not been exposed to anyone who has COVID-19 in the last 14 days. I further state that my child/children are not experiencing, and haven't experienced in the last 14 days, any of the following symptoms as directed by the CDC. (Symptoms may appear 2-14 days after exposure to the virus.)

- Cough
- Shortness of breath; difficulty breathing
- Fever
- Chills
- Muscle Pain
- Sore Throat

This list is not all possible symptoms. Other less common symptoms have been reported, including gastrointestinal symptoms like nausea, vomiting, or diarrhea. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable. If you have been diagnosed, have had exposure to or have experienced any of the above symptoms within the last 14 days- please inform us immediately so that appropriate protective measures can be implemented.

I further state that I will immediately inform Gibbstown School Aged Child Care if any of the above information has changed before my child/children participate in any class or center related gathering.

We ask that you take your child's temperature at home. If it is above 100 degrees; your child will not be able to attend class that day. Your child's temperature will be taken before they are permitted to enter the building. Parents will not be permitted in the building for drop off or pick up. Parents should not leave until the staff member confirms the child has no temperature.

Masks are required to worn at pick up & drop off. Children will need to wear a mask over the course of day. With limits on sharing – please label all of your child's belongings.

I understand that an inherent risk of exposure to COVID-19 exists in any public place where people are present and I acknowledge that Gibbstown School Aged Child Care can not guarantee that my child will not become infected with COVID-19, an extremely contagious disease that can lead to severe illness. I understand the risk of becoming exposed to and/or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others.

By participating in Gibbstown School Aged Child Care classes and all other center related gatherings I voluntarily assume all risks related to exposure to COVID-19 and hereby release and agree to hold Gibbstown School Aged Child Care harmless from any and all causes of action. I understand that signing this release discharges Gibbstown School Aged Child Care from any liability or claim that I may have against the center with respect to any bodily injury, illness, medical treatment, or damages that may arise from, or in connection to, any activities related to Gibbstown School Aged Child Care. This liability waiver and release extends to the center together with the Board of Directors, staff, and class spaces.
