### **Lot Rent Increase**

On July 1<sup>st</sup>, 2019, our rent will go up by \$5.00 to cover additional expenses including the 2018 DEQ mandated repair/reserves, necessary repairs to our equipment and the Orchard View millage. Last year the DEQ mandated all public water systems to initiate a capital expense reserve account. This account is used for repairs to our water system. In 2018 we used this money to refurbish 3 of our generators (these keep the water running when the power is out), replace 4 main valves as well as work done in two of our well houses. This year we will use the money to refurbish the last generator and continue to replace/repair valves throughout the community. The OV millage is to cover repairs to the building and infrastructure at the school. The vote ended up tied after the November election and a recount was done on December 5<sup>th</sup>. Finally, we've seen an increase in repairs to our trucks and tractor. As our equipment ages, repairs become more necessary.

Of the reasons above, keeping our water system running is by far the most important thing we do. If the water system failed or became unsafe, we would be required to hook up to the township's water at an estimated cost of over a million dollars. This would necessitate a much larger rent increase to cover that cost. Leaving that reason aside, we live here also and want our water to be safe and available. This increase will help us make that happen.

We know that a rent increase is never popular. But keep in mind that of the 35 communities in our area, Arlington's lot rent is one of the lowest and the only one that includes water, sewer, cable and trash. 

# **Underground Sprinkling/Irrigation:**



Anyone wanting to install underground sprinkling/irrigation must obtain Management approval prior to installation of any kind. If you have questions regarding this, please see Theresa in the office.

#### Below are the listed requirements:

The plans for Residents sprinkling system and literature for sprinkling heads must be submitted for written approval to Arlington's office prior to construction of the system.

Pipe must be a 100psi NSF and each zone cannot exceed 4 gallons per minute at 40psi. All wiring must be irrigation wire. A Fabco vacuum breaker and shut off valve must be accessible to Arlington.

The installer of the system must be licensed by the State of Michigan and must present proof of general liability insurance with minimum limits of \$100,000.00.

Prior to construction, residents yard must be staked by "Miss Dig" & Private Cable Systems to ensure that construction will not damage underground utilities.

Any damage caused by Residents installer to any of Arlington's property is the responsibility of the resident.

Residents will only sprinkle from midnight until 6:00 am. Times for sprinkling are subject to change by Arlington at any time.

Residents system will be disabled by Arlington for failure to comply with the terms of this agreement and Residents grants to Arlington a license to enter the Residents property for this purpose.

A backflow prevention test will be performed and signed by an ASSE 5110 tester once every 5 years. A copy of the test and certification will be submitted to the community office by June 30th.



### **Odd/Even Watering:**

Properties with addresses that are even (the last number in your address), water on calendar days that are even. Properties with addresses that are odd, water on calendar days that are odd. There will be some even folks that are concerned about getting cheated because if there are 31 days in the month, there are two odd days in a row. Any 31st day of the month will be a "wild card" day and both odd and even addresses can water. However, they are being asked to apply only 50% of the irrigation water that they would normally apply on their normal watering day.

Residents with underground sprinkling are ok to water as they normally would in accordance with the times on the irrigation signed contract that is on file with the office and the DEQ. (Any resident with underground sprinkling MUST have a signed contract on file).

### **Rent Study:**

The following information is from a rent study by JLT & Associates of Henderson, Nevada. This company does rent studies over the entire United States. This study is for manufactured home communities in Allegan, Ottawa & Muskegon counties. The entire study is 78 pages & is available in the office for your review.

The information below show adjusted rents and a comparison for the 35 communities in Muskegon County. Actual rents are adjusted according to the services included in rent. Services that may be included are water (W), sewer (S), trash removal (T), & cable (C).

For Muskegon County water is valued at \$13 per month, sewer at \$32 per month, trash removal at \$14 per month per month & cable at \$40 per month. For Arlington actual rent is is reduced by \$99 per month as water, sewer, trash removal & cable are all included. As the report states only 1 community, Arlington Woods, provides all 4 services.

The report also shows that of the 35 communities, only 3 have lower adjusted rents than Arlington.

As stated the entire report is available at the office for your review.

### From The Office Of Muskegon Charter Township:



Each resident pays a specific tax of \$3.00 per month in their lot rent. This charge is a state tax and is required by the State Tax Commission. This tax does not include personal property and improvements made by the mobile home owner. Muskegon Charter Township sends out two tax bills each year, a summer tax and a winter tax for personal property and improvements made by the mobile home owner. Some residents of Arlington Woods will receive these bills, based on taxable additions on their homesite. Each year an inspection or assessment is completed by the Township on every lot in our community. The Resident will receive a tax bill from Muskegon Charter Township for any of the following improvements:

1.Detached sheds and buildings which are on concrete slabs, posts, piers or skids with or without floors.

2.Attached sheds which are on concrete, posts or piers with or without floors.

3.Attached carports and porches.

4.Concrete floors, walks, patios etc.Which are not part of the pad provided by the park.

5.Attached garages.

6.Wood decks and porches built on site by the owner of the mobile home.

7.Porches with or without chassis.

8.Porches built on site or that are pre-cast and moved to the site.

9.Additions that were built or are not part of the original unit and are without chassis.

10.Wood/Glass enclosed porch, wood/screen enclosed porch, wood covered porch, wood decks, covered wood decks, concrete covered porches, large sheds, etc.

### LOUD MUFFLERS & NOISE REGULATIONS:

Please remember that each resident has the legal right to the quiet enjoyment of his or her own home. Vehicles with faulty or bypassed mufflers are not allowed in our community. Noisy and/or loud vehicles/conduct interferes with your neighbor's enjoyment of their home. Radio's, televisions, stereo's, etc. are to be played at a level that will not interfere with your neighbor. Please consider their right to live in their home undisturbed. Management may terminate a resident's tenancy if the resident, after reasonable written notice and an opportunity to correct his/her conduct, fails to correct any conduct condition that unreasonably annoys his/her neighbor.

### **Arlington Woods 2019 PFAS Results:**

#### Arlington Woods 2019 PFAS Results

Arlington Woods was included in a state-funded quarterly sampling effort because our PFAS results in 2018 were greater than or equal to 10 parts per trillion (ppt) total PFAS or between 10 ppt and 70 ppt perfluorooctanesulfonic acid (PFOS) and perfluorooctaneic acid (PFOA). The results of 2019 PFAS samples collected from Arlington Woods on March 27th, 2019 are below. A copy of the laboratory report in its entirety is in the office for your review.

Currently, there is no regulatory drinking water standard for any of the PFAS chemicals. However, in May 2016, the United States Environmental Protection Agency (USEPA) established a non-regulatory Lifetime Health Advisory (LHA) for two of these chemicals, PFOS and PFOA. The LHA for PFOS and PFOA is 70 ppt combined, or individually if only one of them is present.

Our results are on the chart above, however a summary is listed below:

- PFHxA = 2 parts per trillion (ppt)
- PFOA = 4 ppt
- PFOS = 3 ppt
- Total PFAS = 9 ppt
- PFOA+PFOS = 7 ppt

The first sample collected on 7/6/2018 reported Total PFAS as 12 ppt and where PFOA+PFOS was 5 ppt. Our well will be sampled 3 more times in 2019 as part of a state-funded PFAS monitoring effort. We will notify you of each of these results once they are returned to us.
