#### WINTER REMINDER:

Keep your roof and vents clear of large amounts of snow and ice. This keeps your furnace and any appliances with roof vents running smoothly.

## **SKIRTING & SNOWPLOWS:**

If you live on a corner lot or road with skirting very close to the street, we highly recommend you re-enforce the skirting during the winter months. Some residents have used wood in front of their skirting. Please be sure this is done in a neat and orderly fashion or we will ask that it be removed or redone. When we plow we do so with the utmost care but at the same time we must push the snow from the roads at a high rate of speed which forces the snow into whatever is on the side of the road. With homes and skirting so close on corner lots and some end streets, the skirting is vulnerable to damage. We are informing you in advance to protect your skirting from the winter plowing "harshness" as we will not be responsible for damage from snow.

## COMMUNITY FENCING:

The white fence caps in the North Community are being damaged on a regular basis. We replace them and more are damaged. Please do not climb on or over the fence. Do not permit your children to climb on or over the fence or damage the caps. Parents are responsible for the actions of their children. Leaseholders are responsible for the actions of their guests. ## TENANT WEB ACCESS:

We have had quite a bit of positive response to the Tenant Web Access and are glad many residents are using it. We hope this system works well for many years to come and please do not hesitate to notify us of any issues you come across using the Tenant Web Access and we will do our best to correct it. Here are some things to keep in mind:

- Residents with home payments can only pay their home payment amount due, anything paid above the home payment amount due will be applied to their lot rent.
- In order for residents to pay their lot rent in advance, it must be posted on our end. We have set up our system to post lot rent on the 15th of each month. This will allow residents to pay next months rent if they choose to. You do not have to, but the option is there.
- If you have a problem logging into your account, contact us and we can email you a link or if you need your password reset we can do that as well.
- We do still accept all payments in the office other than cash.
- There is no fee to pay online when payment is made using the auto withdraw from your checking/savings account.
- A 3.5% fee is charged if payment is made using a credit or debit card online.
- You can set up monthly automatic withdrawals.

# AUTOMATIC WITHDRAWALS (ACH):

We can set up automatic withdrawals from your checking/savings account through our office to pay your monthly lot rent without any worries. We are able to extend that same offer for your home payments as well. In short, you will be able to have all of your monthly payments deducted straight from your checking or savings and paid straight to us with no late fees or worries!

Be sure to grab a sign up form if you're interested.

#### TITLE REQUIREMENTS:

All homes in Arlington Woods must be owner occupied, this is done by placing the home in your name at the time of purchase and providing the title to our office at the time of lease signing.

When selling your home, it is a requirement that the title be in the name of the buyer prior to them moving in, taking possession and signing their lease. What this means for you: It is the responsibility of the buyer and seller to properly transfer the title with the Secretary of State at the time of sale. The current lease holder (seller) will be responsible for the home, lot and rent until the qualified buyer signs the lease and presents the title in their name.

### MAIL/DROPBOX SLOT:

A dropbox/mail slot is located on the front of the office, just past the office entrance door and can be used to pay rent or for other communications with the Managers, it is available for use at all times.

## SPEED LIMIT:

BY STATE LAW, THE SPEED LIMIT IN MANUFACTURED HOUSING COMMUNITIES IS 15-MILES PER HOUR. A habitual speeder who refuses to change his/her habits could be evicted for violating the speed limit after being warned in writing three times. Residents are held fully responsible for the speed at which their guest travel while on community property.

## **RESIDENT UPDATES:**

Please remember to keep your account information updated regularly. Emails, phone numbers, vehicles and places of employment are some examples of the information that the office struggles to keep updated. We cannot contact you when needed if we do not have the correct information on your account.

## **RENT, TERMS & OCCUPANCY:**

Rent is due on the first day of each month.

A one time per month late fee of \$25.00 will be added to the rent account on the 10th day of each month.

Late fees are removed for any payment in the drop box the morning of the 10th. You can also pay online until midnight of the 9<sup>th</sup> day to avoid the late fee. We accept credit, debit, check, money order , online payments through our Tenant Web Access or you may sign up for auto withdraw (a form must be completed in the office).

A \$25.00 Charge will be added to your rent account for any check that is returned by the bank for insufficient funds.

Rent is based on the occupancy of the home by two (2) people. An additional charge of \$5.00 per month for each additional person will be charged for occupancy of additional people.

An charge of \$5.00 per month is made if you have an animal (cat or dog) living in your home.
